- Perform complex medical procedures, such as administering medications, ventilator management, and providing life support interventions
- Collaborate with patients, their loved ones, and multidisciplinary teams to develop and implement individualised care plans for patients
- Respond promptly to changes in patient conditions and initiate appropriate interventions
- To practice within the NMC The Code: Professional Standards (2015) and adhere to this at all times
- To support and assist in the health education of patients and their families
- To ensure care is delivered in accordance with latest evidence based practice guidelines



- Advocate for patients' needs and preferences, ensuring their rights and dignity are respected
- Provide emotional support to patients and their families, addressing concerns and facilitating communication between healthcare providers and family members.
- To maintain up to date and comprehensive records of care in accordance with NMC and legal requirements
- To support junior colleagues, students, and visitors to the department
