Summary of the role:

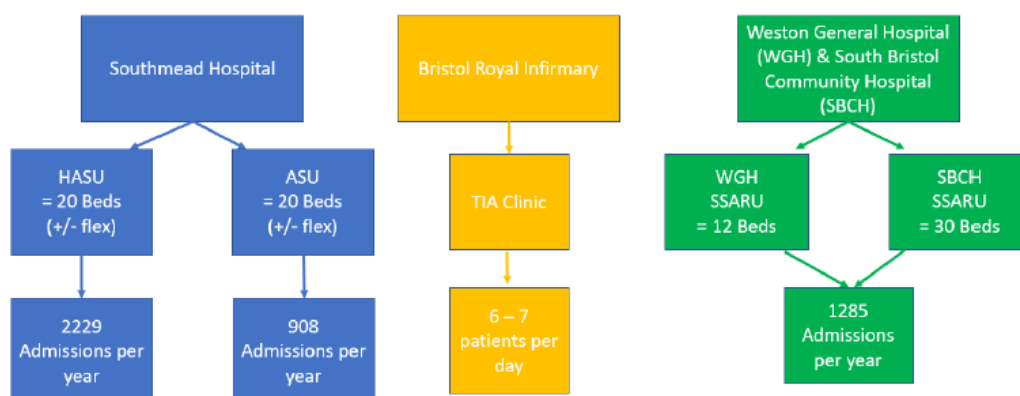
We are looking for a Consultant Stroke Physician to join an expanding and forward-thinking department providing acute stroke services for the entire population of Bristol, North Somerset and South Gloucestershire (BNSSG), along with regional provision including Mechanical Thrombectomy to the wider Severn Region and beyond.

Stroke services have been centralised to the Comprehensive Stroke Centre (at Brunel Building, Southmead Hospital) from May 2023 with an expansion of the hyperacute stroke unit (HASU). The acute stroke unit (ASU) is based at Southmead Hospital also.

The post holder will be required to support the delivery of acute services, alongside outreach support to Mon-Fri transient ischaemic attack (TIA) Clinics and ward referrals at the Bristol Royal Infirmary. They will also be expected to support bi-weekly ward consultant rounds at the Stroke Sub Acute Rehab Units (SSARU's) located at South Bristol Community Hospital and Weston General Hospital. Department:

The stroke service sits as part of the Neuro and Musculoskeletal (NMSK) Division and is a major part of the Regional Neurosciences Centre. The other components of the Neuroscience Centre include Neurology, Neurosurgery, dedicated Neuropathology, Neuroradiology, Clinical Neurophysiology, Neuropsychiatry, and Neuropsychology.

There is a Brain Injury Rehabilitation Unit on the Frenchay site, run by Active Care Group with close links to North Bristol NHS Trust (NBT)

We are an active research department led by Dr Philip Clatworthy, a Stroke Association Thompson Family Senior Clinical Lectureship in the University of Bristol, working on real-world individualised rehabilitation in visual loss due to stroke. We actively recruit to NIHR stroke clinical trials and are looking to expand our research portfolio as the department grows.

The new post-holder will be given appropriate secretarial support and office space will be available within the Stroke department (Gate 3, Level 2 Brunel Building.)

Regarding the Trust more broadly, NBT is a progressive and ambitious provider of health services, delivering for a large local population and with specialist regional services for major trauma, neurosciences, vascular centre, urology, plastics and burns, orthopaedics and renal services. With a turnover of £550m and 9,000 staff, our clinical teams have built a strong reputation for exceptional healthcare.

Our acute services moved into a brand new, state of the art, hospital building in May 2014. This modern 850 bed facility at the Southmead site offers patients single rooms with en-suite facilities, greatly improving privacy and dignity and reducing the spread of infections.

There are 3 stroke registrars, 1 Specialty Doctor and an expanding team of senior clinical fellows and other junior doctors. We have 3 stroke physician associates. In addition, there is a growing team of advanced nurse practitioners who support the stroke pathway. We also now have 3 advanced clinical practitioners in post.

We have an excellent neurovascular interventional radiology service and we boast a world class thrombectomy team and lead the Severn Stroke Thrombectomy Service and Thrombectomy Network.

Communications and Relationships:

The post holder will be expected to have excellent communication skills, both written and verbal, to enable effective communication about medical topics with patients and colleagues. The post holder will be empathetic and sensitive to patients needs and able to explain things clearly – particularly complex or sensitive information. The post holder will be required to work in

partnership with colleagues of all disciplines, external links to the Trust and service users, to ensure the creation of a quality service. The post holder will be expected to commit to shared goals in the department by building effective teams and partnerships and valuing the roles and contributions of others.

Responsibility for Patient Care:

The post holder will have continuing responsibility for the care of patients in his or her charge and for the proper functioning of the service and will undertake the administrative duties associated with the care of patients and the running of the clinical department. The post holder will be required to work in partnership with colleagues of all disciplines, external links to the Trust and service users, to ensure the creation of a quality service.

The postholder will be responsible for the clinical management of Stroke patients under their care, and, in liaison with consultant colleagues, continuity of care when the postholder is absent.

The postholder will join the existing team of stroke Consultants and share the supervision of the acute stroke provision at Southmead Hospital, during normal working hours and on call, including responsibility for thrombolysis and thrombectomy. In addition, the postholder will support outreach to peripheral TIA clinics and rehabilitation units.

The successful applicant will be a team player and be willing to work flexibly to provide cover for the other consultants who cover the Stroke Services. There will be consideration of time of in lieu for e.g. weekend working.

The successful applicant can be from any parent speciality but must have experience in stroke care. The job plan and total clinical commitment in stroke will be adapted to be suitable to the appointee, but the majority of their time will be in stroke. Outpatient clinics follow ABN guidelines and agreed template with 30 mins for new, and 15 mins for follow up. Current clinic duration is 3 hours.

The essential requirement is that the appointee be expert in and committed to the care and management of people with stroke in all phases of their care, be committed to helping build a stroke centre of excellence both in patient care and research.

The successful applicant would join the current stroke consultants who cover the stroke activity on a rotation system. The clinical model will be 5 consultants providing hyperacute stroke service and acute stroke unit care at North Bristol Trust, with approximately 2229 stroke admissions annually, with an additional consultant visiting Bristol Royal Infirmary Monday to Friday. Finally, there will also be consultant visits to the SSARU's located at South Bristol Community Hospital and Weston General Hospital. The successful applicant as part of their on call would be expected to provide timely reviews of all admissions, with the HASU consultant providing a formal post take round after morning board round and afternoon board round.

Finally, there may be the opportunity to develop a sub specialty clinical interest (e.g. clinic).

Responsibility for financial / physical resources and policies:

The post holder will be expected to adhere to Trust policy and procedures as well as contributing to policy and service development. The post holder should have enough understanding of NHS financial management in order to provide the best service possible. They will minimise waste, improve services, and promote effective use of resources available.

The Post holder should understand the roles and policies of local and where relevant national agencies involved in healthcare.

Responsibility for People Management:

The Post Holder will be expected to provide compassionate leadership to their clinical teams. This may include multi-agency teams within Primary and Secondary Care. They will be

responsible for the supervision of junior staff within their team and will lead by example and with compassion.

Teaching and Supervision of Junior Medical Staff & Students:

We aim to support the development of all our doctors, whilst maintain an environment where patient and staff safety is paramount. A key element of that is ensuring high quality clinical and educational supervision. The postholder will be responsible for the professional supervision and management of junior medical staff. Where appropriate, the postholder will be named in the educational contract of junior staff as the person responsible for overseeing their training and as an initial source of advice to such doctors regarding their careers. Time will be allocated within job plans to support this activity.

In liaison with the Director of Postgraduate Medical Education the postholder may be required to contribute to undergraduate and postgraduate education.

Research and Development:

At NBT we have a well-established Quality Improvement programme and the post holder will contribute to this. There are also opportunities for clinical audits both locally and nationally the the post holder will support more junior staff with this activity.

The postholder can request up to a maximum of 30 days study leave within a 3-year period (pro rata for part-time posts) as stated in the Terms and Conditions of Service.

The Trust is committed to ensuring that support is given for Continuing Medical Education. The postholder will be required to fulfil the requirements laid down by the relevant Royal College, and to fulfil the requirements for revalidation laid down by the General Medical Council. The department participates in a weekly regional neuroscience meeting during term time.

The postholder will not necessarily be expected to undertake research however excellent opportunities exist to be actively involved in clinical research both as a principal investigator for clinical network studies and in our own portfolio of clinical stroke research. The post holder will be supported to develop own research in collaboration with other departments within Trust or with the University of Bristol and the University of the West of England. The postholder will be required to take part in a Clinical Audit Programme. The Trust has an audit department which supports and monitors such activity. There is an active Trust Clinical Audit Committee.

Partnership working:

The post holder will be required to work in partnership with colleagues of all disciplines, external stakeholders and service users, to ensure the creation of a quality service. The will commit to shared goals in the department by building effective teams, valuing the roles and contribution of others.

Equality and Diversity:

At NBT our culture is one of true inclusivity and aims to positively eliminate discrimination by promoting a diverse and inclusive culture. As a minimum the post holder will ensure that their own actions support diversity and equality and they will comply with policies, accept differences and treat all with dignity and respect.

Personal Development:

At NBT we are committed to supporting all staff with their personal and career development and also developing our aspiring leaders. Access to relevant study leave will be available, subject to discussion and agreement of the department clinical lead.

Main conditions of service:

This appointment is subject to the terms and conditions – Consultants (2003) and any current amendments. The post holder will be expected to be aware and comply of local policies and procedures as well as comply with all Trust standing orders and standing financial instructions. All offers of employment are subject to pre-employment clearances.

The appointee will be expected to work within the facilities available to the Group and any new service developments are subject to the provision of necessary resources within the Trust. There is an active appraisal and development programme and all consultant staff will take part in this process.

The post holder must be fully registered with the General Medical Council with a licence to practise and is advised to maintain up to date membership of a recognised medical defence organisation.

The Trust has arrangements in place to ensure that all Medical staff receive an annual appraisal with a trained appraiser and supports all Medical staff through the revalidation process.

The Trust has a list of identified Mentors which is used to allocate a suitable support to new consultants during the first year in post

The appointee will be required to live within a distance that allows safe discharge of all clinical commitments and no more than a 10 mile distance from the base (unless there is prior agreement with the Medical Director) or 30 minutes travelling of your base hospital.

An applicant who wishes to work less than full-time will be eligible to be considered for the post; if such a person is appointed, modification of the job content will be discussed with the Trust on a personal basis in consultation with Consultant colleagues.

The successful candidate is expected to be aware of local policies and procedures and comply with the standing orders and standing financial instructions of the Trusts.

Consultant appointments are made to North Bristol NHS Trust as services are developed and changed, the base of posts may alter and any employee of the Trust will be expected, within an agreed clinical strategy, to move his/her sessions as the service requires.

Job Plan:

The job plan will be reviewed prospectively and at least annually. This will be a positive agreement that sets out a Consultants duties, responsibilities and objectives for the coming year.
