<b>2. Job Purpose:</b>	To provide a range of dental treatment for priority groups and patients referred to the CDS according to Health Board/Directorate policy.
<b>3. Duties and Responsibilities</b>	<p><b>Clinical:</b></p> <ul style="list-style-type: none"><li>• Undertake thorough examination and assessment of patients who fall within the remit of the CDS in Wales and according to Directorate policy.</li><li>• Plan and manages care for a range of patients at clinic sites and/or by utilising mobile dental units / hospital venues.</li><li>• Undertake domiciliary care according to Directorate Policy.</li><li>• Liaise with other professionals and/or carers as necessary.</li><li>• Plan, develop, implement and evaluate appropriate interventions to prevent disease and promote health for individual patients.</li><li>• Participate in oral health promotion initiatives as required.</li><li>• Able to identify commonly occurring medical emergencies and lead the dental team in the appropriate first line management of the emergency, using appropriate techniques, equipment and drugs.</li><li>• Use appropriate local anaesthesia and patient management approaches to control pain and anxiety during dental treatment.</li><li>• Use of inhalation sedation and other means of controlling anxiety where required.</li><li>• Provide dental treatment under general anaesthesia where required.</li></ul>

- Undertake the diagnosis, selection of appropriate periodontal techniques and delivery of periodontal care in an effective way.
- Routine exodontia and simple surgical exodontia.
- Undertake appropriate assessment of patients to determine the need for specialist advice.
- Undertake appropriate investigations during patient examination to determine the need for specialist advice in the management of the developing dentition.
- May undertake orthodontic treatment to a specialist/consultant treatment plan subject to appropriate accreditation.
- Undertake the diagnosis, selection of appropriate restorative or replacement of teeth in an effective way.
- Participate in oral health assessments/agreed screening programmes for identified target groups as required.

### **Communication:**

- Communicate with a range of patients and families on individual clinical issues.
- Communicate with all members of the clinical team and peers in an appropriate manner.
- Communicate appropriately with other health and social care professionals involved in the care of patients.
- Communicate by representing the CDS at meetings or delivering lessons/ lectures as required.
- Is cognisant of Information Governance requirements.

### **Management and Leadership:**

- Responsible for the organisation and running of the immediate clinical environment and the dental team.
- Understand the legislative framework governing the delivery of oral health care in Wales.
- Understand the financial framework governing the delivery of oral health care in Wales and the constraints that might impose on service delivery.
- Commitment to fulfilling service contract specifications and data collection requirements.
- Understand and put into practice the leadership of the immediate dental team, Dental Care Professional and administrative staff.

- Understand the responsibility for health and safety issues.
- Participate in Quality & Safety (clinical governance).

### **Professionalism:**

- Demonstrate and apply the principles of ethical behaviour relevant to dentistry, including honesty, confidentiality, personal and professional integrity and compliance with the standards for dental professionals laid down by the GDC.
- Offer and provide care to patients within a sound ethical and professional framework.
- Demonstrate a professional clinical approach, including participation in appraisal, peer review, clinical audit and continuing professional development activities.
- Behave in a professional way towards the clinical team and peers and understand responsibilities with regard to issues such as poor or under performance.

### **Teaching and Training:**

- Participate in the training of individuals on a local clinical basis.
- May undertake teaching/supervision/mentorship as part of a predetermined programme for other staff, trainees and/or undergraduate dental students.
- May participate in dental epidemiological fieldwork.
- May participate in clinical research as part of an approved research programme.
- Provision of clinical supervision for DCT (1) if relevant.

- Defnyddio tawelydd anadlu a dulliau eraill o reoli pryder ble bo angen.
- Darparu triniaeth ddeintyddol o dan anesthesia cyffredinol ble mae angen.
- Ymgymryd â rhoi diagnosis, dethol technegau periodontol a rhoi gofal periodontol mewn ffordd effeithiol.
- Echdynneg arferol ac echdynneg llawfeddygol syml.
