Key Responsibilities – All roles

- Assist in all areas of care in accordance with agreed care plans and procedures to enable people using services to meet their individual needs.
- Conduct, record and report observations, and ensure care plans are implemented and quality standards achieved.
- Monitor the wellbeing of people using services
- Actively engage people using services, particularly those on higher level of observations and with greater care needs, in therapeutic conversation and activities.
- Undertake physical health checks, i.e. Blood Pressure, Temperature, Respirations, CPR and use of Defibrillator
- Explain principles, techniques, and safety procedures to participants in activities and demonstrate use of materials and equipment.
- Encourage and support individuals to take part in activities suited to their particular needs and interests.
- Provide and promote recovery-orientated support and low intensity therapeutic interventions to people using services in a way that respects their views, autonomy and culture.
- Attend and contribute to meetings, ward reviews and care programmes meetings as appropriate.
- Assist in assessing of risk and developing care plans.
