JOB PURPOSE

The regional North West Ventilation Service (NWVS) cares for patients with a wide variety of conditions all resulting in chronic respiratory failure, many have extremely complex needs and require highly specialist care. The job holder will be responsible for the following

- Independently providing a wide range of advanced / complex respiratory measurements and developing new and innovative tests.
- Providing a wide range of ventilation therapies to patients with complex respiratory diseases.
- Training, mentoring and assessing multidisciplinary healthcare staff from inside and outside of the organisation
- Responsible for ensuring the technical accuracy and quality of the test procedures and producing accurate reports based on these procedures.
- To communicate effectively with staff and patients.

The post holder will work as part of the Multi Disciplinary Team (MDT) which includes consultants, specialist registrars, junior medical staff, nursing staff and physiotherapists and will be expected to take part in a day, night, weekend and bank holiday duty roster as required.

Principal duties and responsibilities

- To assess all in patients and ensure that they have appropriate respiratory measurements completed during their admission by both referral to and by liaison with the respiratory physiologists or by performing the tests independently.
- Provide a wide range of advanced / complex respiratory measurements and ensuring the technical accuracy and quality of the test procedures (including producing accurate reports based on these procedures) as required to support the North West Ventilation service patients.
- Responsible for establishing patients on long term non-invasive ventilation
- Ensuring optimum ventilator settings are determined and trouble shooting ventilator related problems on the ward for patients who are ventilated both invasively and non-invasively and for those weaning from tracheostomy ventilation.
- Providing education teaching to patients and relatives regarding the ventilation equipment prior to discharge for non invasive ventilation, and tracheostomy ventilation.
- Play a supportive and technical role during the twice weekly consultant lead out patient clinics including technical assessment of ventilator equipment and assessment of respiratory physiology.
- Supervision, training and mentoring of junior MDT staff and rotational physiotherapy staff
- Request / perform diagnostic interventions including:
 - advanced / complex respiratory physiological measurements
 - requesting and interpretation of pulse oximetry / transcutaneous CO₂ monitoring
 - performing and interpreting invasive earlobe blood gas measurements
 - Detailed spirometry with Flow Volume Loops
 - Assess Muscle Pressures

- Co-ordinate detailed Sleep studies
- Participate within the team of physiologists providing the NWV out of hours on call service
- Participate in the weekly meetings with the Cystic Fibrosis team and the long term ventilation MDT.
- Ensuring relevant information is passed correctly and updated regularly to the outside agency dealing with patient equipment.
- Participate in improvement of services and the quality of care provision.
- Support and participate in on going clinical research within long term ventilation.

Professional, Technical and Clinical

- Perform, unsupervised, all routine daily requirements of the post
- Perform unsupervised, all routine techniques within the lung function laboratory as required. Undertake additional training in routine and specialist techniques as required.
- To undertake regular equipment testing including calibration, maintenance and quality control.
- To ensure the technical quality of testing and lung function reporting complies with published national guidelines.
- Ensure compliance with all aspects of legal and ethical obligations.
- Participate in the on call rota to ensure 24-hour cover for NWV patients and maintenance of satellite blood gas analysers.
- Ensuring the ventilators and associated equipment are serviced, repaired and maintained as appropriate.

Managerial / Leadership.

- Organisation of respiratory physiology measurements in inpatients and out patients and to supervise the quality control of those measurements.
- To supervise and mentor the work of junior MDT members.
- To participate in the evaluation and testing of new equipment and maintain performance and monitor technical problems of existing equipment.
- Participate in cost awareness and cost control policies in the department.
- Contribute to effective multi disciplinary teamwork within the North West Ventilation service.
- Participate in Ward / Department meetings at which broad professional and service issues are discussed.
- Use available IT resources as per Trust Guidance.

Education and Development

- Deliver training to technical staff and other health professionals as required
- Participate in the development of department policies, protocols and standard operating procedures. E.g respiratory physiology protocols.
- Provision of training to delegates attending internal and external training courses.
- To maintain awareness of current advances and changes in clinical practice.
- Maintain commitment to research based practice and clinical excellence.
- Demonstrate responsibility for personal professional development using Personal Development Plan and Professional Portfolio.

Infection Control

As member of a clinical team your personal contribution to reducing healthcare associated infections (HCAIs) require you to be familiar with the Trust's Infection Control Manual including the Hand Decontamination Policy, Personal Protective Equipment Policy, safe procedures for using aseptic techniques and safe disposal of sharps. Supplementary information

Effort and environment factors

Physical Effort

There will be frequent times when it will be necessary to exert moderate physical effort for short periods during the working day. This involves moving heavy patients in wheel chairs, ventilators weighing > 8 kg and stock orders.

Mental Effort

Concentration and accuracy are required in all aspects of this post. There will be frequent times when attention to detail is required such as completing the patient database and performing, assessing and interpreting patients lung function tests.

Emotional Effort

There will be frequent time when it will be necessary to deal with difficult patients or distressing and / or emotional situations involving patient's disease and treatment.

Working Conditions

There will be frequent times when it will be necessary to deal personally with body fluids including blood, urine and sputum. Home visits will be required.
