PLEASE TICK CATEGORY/CATEGORIES THE ROLE INVOLVES ☐ Role includes exposure prone procedures (EPP)/ Renal Dialysis (RD) **EPP:** invasive procedures where there is a risk that injury to the worker may result in exposure of the patient's open tissues to the blood of the worker. These include procedures where the worker's gloved hands may be in contact with sharp instruments, needle tips or sharp tissues (e.g. spicules of bone or teeth) inside a patient's open body cavity, wound or confined anatomical space where the hands or fingertips may not be completely visible at all times. Taking blood (venepuncture), setting up and maintaining IV lines, incision of external abscesses and simple endoscopic procedures are not considered EPP activities. RD: undertaking haemodialysis or haemofiltration i.e. dialysis unit/ICU including renal nurses. □ Role is patient facing and/or handling clinical specimens (NON EPP/RD) Patient facing: clinical roles (doctors, nurses, allied health), porters, cleaning staff, catering etc. Any role with direct contact with patients. Handling clinical specimens: roles which involve the taking, transporting and testing of clinical specimens. Role is NON patient facing and does not involve handling clinical specimens: office based staff including offices within clinical areas. Role includes food handling: only those involved in producing, preparing and handling food.

*Re: Work in confined space (B20 on FRF below). It can be any space of an enclosed nature where there is a risk of death or serious injury from hazardous substances or dangerous conditions (e.g. lack of oxygen). Some confined spaces are fairly easy to identify, e.g. enclosures with limited openings, enclosed drains and sewers.
