JOB SUMMARY

The purpose of this job is to provide administrative support for the Biologics service in Rheumatology, supporting the Clinical Team by dealing with telephone queries, booking Biologic infusions via Fred Bulmer using Maxims and ChemoCare, applying for funding, Homecare prescription management and maintaining a database. This role is based in the Rheumatology Biologics department but there is a need to be flexible in working throughout the Department as service needs require.

MAIN FUNCTIONS OF THE ROLE

- Audio typing and reviewing patient letters and reports from digital dictation.

- Forwarding letters/reports by either: - post, telephone or e-mail as required.
- Answering departmental phone calls in a courteous and professional manner.
- To liaise with patients and provide non clinical advice such as dates and times of clinic appointments.
- To be able to assess nature of enquiry and deal with appropriately, asking advice from the Band 4 Biologics Co-ordinator or Clinicians as necessary.
- Open, prioritise and date stamp mail daily.
- To use own initiative and manage own work load under the guidance of the Band 4 Biologics Co-ordinator.
- Ensure all patient notes retained in the office or sent out of the office are traced on Patient Administration System (EPR Maxims).
- Download pathology results from ordercomms on Maxims for patients' results on request from Clinician.
- Liaise with treatment units ie. Fred Bulmer Medical Day Case Unit, Charles Renton Unit regarding patients' impending admissions for procedures and transfer of medical notes to the relevant department if needed.
- Update ChemoCare with patient infusions and specific details on an ongoing basis.
- Send out admission letters in a timely manner with patient information.
- Make sure the notes are complete, correspondence filed and follow-up action taken.
- Obtain urgent radiology reports off the computerized reporting system when required.
- Maintain an up-to-date knowledge of Departmental procedures and updating Standard Operating Procedures on an ongoing basis.
- Obtain patients' hospital notes from Health Records and other Departments.
- To understand the 18 week pathway for patients and undertake any relevant training required.
- To be able to undertake validation of data quality and 18 week tracking of patients with the guidance of the Band 4 Biologics Coordinator.
- Booking and changing of patients' out-patient appointments as required either via the Biologics future appointment worklist in chronological order or from instructions post a clinic review with a Consultant for example, adhering to Trust's waiting time targets, ensuring 18 week rules and NICE guidelines are adhered to, delegating to Band 2 Admin Assistants if needed.
- Registering patients on Maxims if necessary.
- To be able to outcome clinics on Maxims.
- Ensure patient investigations/results are reviewed by Consultants before filing in notes.
- Arrange for prescriptions to be sent to pharmacy in a timely manner for patients attending for treatment or for outpatient collection and complete the relevant emails from the Pharmacy, patients and home care companies.
- Book interpreters for appointments as required.
- Use of IEP to send images to other hospitals.
- Put patients on EPR Maxims waiting lists as required.
- Ensure patients have appropriate on-going out-patient appointments to comply with NICE guidance.
- Liaise with treatment suppliers to ensure accurate records and timely delivery of medical to patients.
- Apply for funding for biologics treatment and liaise with relevant CCGs, dealing with queries as appropriate in the band 4's absence.
- Management of Homecare prescriptions, ensuring patients are followed up appropriately.
- Update biologics database in accordance with CCG requirements ensuring correct and up to date information at all times.
- Interrogate the database as required and provide information to monthly Biologic Meetings.
- To be able to provide cover for Band 4 Biologics Co-ordinator in times of absence.

Personal Development:

- To maintain up to date skills as required to provide an efficient service.
- Maintain a full and comprehensive knowledge of medical and drug terminology, and theoretical knowledge of procedures carried out within the department.
- To attend/complete all mandatory training, ie. attend courses or by e-learning.
- Minimise hazards in the working area and report any identifiable hazards to the line manager.
- Maintain personal portfolio and attend annual staff performance and development review (SPDR) annually with Admin Lead.

Similarly, no information of a personal or confidential nature concerning individual members of staff should be divulged to anyone without the proper authority having first been given. Failure to observe these rules will be regarded as serious misconduct, which could result in serious disciplinary action being taken including dismissal.

The post holder will be required to comply with all policies and procedures issued by and on behalf of Wye Valley NHS Trust, which the Trust may amend from time to time.

Recorded information includes: patient information entered in case notes and entered on any computerised care records system, financial information, and health & safety information e.g. incident reporting and investigation, personnel information recorded in personnel files etc. Failure to adhere to these principles will be regarded as a performance issue and will result in disciplinary action.
